## **Annual Meeting Summary**

For those who could not make it to the get-together April 22nd, following are a few of the highlights

Final vote tallies for the Peaceful Valley Property Association Board of Directors were as follows:

- Julia Baker, current President, 148 votes

lot, to cover general inflation for services: Yes, 217 votes; No, 24 votes; Abstentions, 21 votes

The vote for a change in the by-laws/abstract, to allow for 2/3rds of voting members rather than 2/3rds of total association membership, will stay open for a year in order to arrive at a full 2/3rds vote

There was also a discussion and demand vote regarding the new 40 mph speed limit and horsepower limit of 300 for vessels on the lake. Julia explained the reason behind the new limits is driven by insurance requirements and well researched, not an arbitrary decision. When the vote was called, 11 voted to remove the new restrictions and 27 voted to keep them as written.

The security gate project is advancing this year, with concrete work starting in May on the upper entrance. You will see construction for 2-way traffic and a turn around. The area also requires drainage culverts and landscaping. Resurfacing on Peaceful Valley Road will be delayed until early 2024 because heavy equipment will be coming through to build a \*new waste water treatment plant. The lower entrance is ready for the next step already. We still need donations to complete the project, having committed nearly all collected funds, \$27,000, to advance to this stage. \*About that treatment plant, Public Water Supply District (PWSD) #1, Gasconade County, managing water and sewer systems for the lake, is entering the construction phase for the new wastewater treatment plant.

Mike Garlock, the district Board President, said construction is expected to begin in July. The completion deadline, per the Missouri Department of Natural Resources (DNR), is the end of 2023. However, if construction needs to continue into early 2024, the PWSD will request a short extension from the DNR.

The plant will be located behind the dam, at the end on the Lake Shore Drive side of the complex. You will see traffic and heavy equipment between the upper entrance and the dam as crews build a new wastewater treatment complex there.

**And finally**, Karen Hoemeke and Megan Jost (the new board Treasurer) signed people in. Anita Oldfather also helped with registration and was official Election Judge. Cheryl Altemeyer is Auditor. Gary and Ricki Hacker handled logistics for a companiable lunch. Big thank you to them and everyone who pitched in to put all the chairs away at the Lodge.
